Instructions

For this activity you will need tape B and scissors \r{K} . If you are accessing this activity from the USCIS <u>Citizenship Resource Center</u>, then you will need a printer.

- Cut out the cube template.
- Fold into a cube.
- Tape flaps down. 🗐

TIP: Have older children help you assemble the cube.

To get the conversation going

- Place cube on any surface along with the six flash cards.
- Take turns rolling the cube.
- Pick up the flash card that matches the picture on the top of the cube.
- Read the flash card together.
- Then discuss the question on the back of the card. Let every family member express at least one opinion about the question.
